Re: HealthLink and Land of Lincoln Health™ Open New Opportunities for Health Care Access


Dear Participating Provider:

HealthLink and Land of Lincoln Health have joined together to offer access to high quality doctors and hospitals for Illinoisans seeking health insurance coverage. Land of Lincoln Health is Illinois' first and only consumer-operated and oriented health insurance organization (CO-OP) as defined by the Affordable Care Act (ACA).

Effective January 1, 2014, individual consumers or small employers that purchase Land of Lincoln Health insurance coverage through the Illinois Health Insurance Marketplace will have access to HealthLink's Open Access III provider network. We would like to take this opportunity to show you how new Land of Lincoln Health member ID cards will provide information you need to identify HealthLink members and submit claims.

Member Identification: Land of Lincoln Health and HealthLink as the Primary Networks (Chicago Metro)

Land of Lincoln Health members residing in Cook, DuPage, Lake, McHenry and Will counties will have access to care from providers participating in the HealthLink Open Access network and Land of Lincoln Health PPO network. For the majority of members in the Chicago Metro area, HealthLink and Land of Lincoln Health will be the primary provider networks as identified by the logos on the **front** of the member ID card. These members also have access to travel networks identified by the PHCS (Extended PPO) and UniCare (including IN, KY, and WI) logos on the **back** of the member ID card. Determining the Co-Payment for Your Land of Lincoln Health Patient with HealthLink OA III Logo on ID Card

If you are a provider with a direct contract with Land of Lincoln Health, the co-payment designation on the member's ID card is at the "preferred" copayment rate.

If you are a provider with a direct contract with HealthLink only, the co-payment designation on the member's ID card is at the "in-network" copayment rate.

Member Identification: Land of Lincoln Health and PHCS as the Primary Network (Northwest Illinois)

Land of Lincoln Health members residing in the northwest Illinois region (Boone, Bureau, Carroll, Henderson, Henry, Jo Daviess, Lee, Mercer, Ogle, Rock Island, Stephenson, Warren, Whiteside and Winnebago counties), will have access to care through the PHCS network and Land of Lincoln Health PPO network as identified by the logos on the **front** of the member ID card. These members also have access to travel networks identified by the HealthLink Open Access and UniCare (including IN, KY, and WI) logos on the **back** of the member ID card. Determining the Co-Payment for Your Land of Lincoln Health Patient with PHCS Logo on the ID Card

If you have a direct contract with Land of Lincoln Health, the co-payment designation on the member's ID card is at the "preferred" copayment rate.

If you have a direct contract with PHCS only, the co-payment designation on the member's ID card is at the "in-network" copayment rate.

Claim Submission

When Land of Lincoln Health members present an ID card, please provide medical care and submit claims to HealthLink, Inc., or send claims electronically using the HealthLink EDI vendor number on the back of the member ID card.
